A BILL

To amend title 5, United States Code, to provide for special base rates of pay for wildland firefighters, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Wildland Firefighter
- 5 Paycheck Protection Act of 2025".
- 6 SEC. 2. SPECIAL BASE RATES OF PAY FOR WILDLAND FIRE-
- 7 FIGHTERS.
- 8 (a) IN GENERAL.—Subchapter III of chapter 53 of
- 9 title 5, United States Code, is amended by inserting after
- 10 section 5332 the following:

1	"§ 5332a.	Special base rates of pay for wildland fire-
2		fighters
3	"(a)	Definitions.—In this section—
4		"(1) the term 'firefighter' means an employee
5	who-	<u> </u>
6		"(A) is a firefighter within the meaning of
7		section 8331(21) or section 8401(14);
8		"(B) in the case of an employee who holds
9		a supervisory or administrative position and is
10		subject to subchapter III of chapter 83, but
11		who does not qualify to be considered a fire-
12		fighter within the meaning of section 8331(21),
13		would otherwise qualify if the employee had
14		transferred directly to that position after serv-
15		ing as a firefighter within the meaning of that
16		section;
17		"(C) in the case of an employee who holds
18		a supervisory or administrative position and is
19		subject to chapter 84, but who does not qualify
20		to be considered a firefighter within the mean-
21		ing of section 8401(14), would otherwise qualify
22		if the employee had transferred directly to that
23		position after performing duties described in
24		section 8401(14)(A) for at least 3 years; or
25		"(D) in the case of an employee who is not
26		subject to subchapter III of chapter 83 or chap-

1	ter 84, holds a position that the Office of Per-
2	sonnel Management determines would satisfy
3	subparagraph (A), (B), or (C) if the employee
4	were subject to subchapter III of chapter 83 or
5	chapter 84;
6	"(2) the term 'General Schedule base rate'
7	means an annual rate of basic pay established under
8	section 5332 before any additions, such as a locality-
9	based comparability payment under section 5304 or
10	5304a or a special rate supplement under section
11	5305;
12	"(3) the term 'special base rate' means an an-
13	nual rate of basic pay payable to a wildland fire-
14	fighter, before any additions or reductions, that re-
15	places the General Schedule base rate otherwise ap-
16	plicable to the wildland firefighter and that is ad-
17	ministered in the same manner as a General Sched-
18	ule base rate; and
19	"(4) the term 'wildland firefighter' means a
20	firefighter—
21	"(A) who is employed by the Forest Serv-
22	ice or the Department of the Interior; and
23	"(B) the duties of the position of whom re-
24	late primarily to wildland fires, as opposed to
25	structure fires.

1	"(b) Special Base Rates of Pay.—
2	"(1) Entitlement to special rate.—Not-
3	withstanding section 5332, a wildland firefighter is
4	entitled to a special base rate at grades 1 through
5	15, which shall—
6	"(A) replace the otherwise applicable Gen-
7	eral Schedule base rate for the wildland fire-
8	fighter;
9	"(B) be basic pay for all purposes, includ-
10	ing the purpose of computing a locality-based
11	comparability payment under section 5304 or
12	5304a; and
13	"(C) be computed as described in para-
14	graph (2) and adjusted at the time of adjust-
15	ments in the General Schedule.
16	"(2) Computation.—
17	"(A) IN GENERAL.—The special base rate
18	for a wildland firefighter shall be derived by in-
19	creasing the otherwise applicable General
20	Schedule base rate for the wildland firefighter
21	by the following applicable percentage for the
22	grade of the wildland firefighter and rounding
23	the result to the nearest whole dollar:
24	"(i) For GS-1, 42 percent.
25	"(ii) For GS-2, 39 percent.

1	"(iii) For GS-3, 36 percent.
2	"(iv) For GS-4, 33 percent.
3	"(v) For GS-5, 30 percent.
4	"(vi) For GS-6, 27 percent.
5	"(vii) For GS-7, 24 percent.
6	"(viii) For GS-8, 21 percent.
7	"(ix) For GS-9, 18 percent.
8	"(x) For GS-10, 15 percent.
9	"(xi) For GS-11, 12 percent.
10	"(xii) For GS-12, 9 percent.
11	"(xiii) For GS-13, 6 percent.
12	"(xiv) For GS-14, 3 percent.
13	"(xv) For GS-15, 1.5 percent.
14	"(B) Hourly, daily, weekly, or bi-
15	WEEKLY RATES.—When the special base rate
16	with respect to a wildland firefighter is ex-
17	pressed as an hourly, daily, weekly, or biweekly
18	rate, the special base rate shall be computed
19	from the appropriate annual rate of basic pay
20	derived under subparagraph (A) in accordance
21	with the rules under section 5504(b).".

- 1 (c) Prevailing Rate Employees.—Section 5343
- 2 of title 5, United States Code, is amended by adding at
- 3 the end the following:
- 4 "(g)(1) For a prevailing rate employee described in
- 5 section 5342(a)(2)(A) who is a wildland firefighter, as de-
- 6 fined in section 5332a(a), the Secretary of Agriculture or
- 7 the Secretary of the Interior (as applicable) shall increase
- 8 the wage rates of that employee by an amount (determined
- 9 at the sole and exclusive discretion of the applicable Sec-
- 10 retary after consultation with the other Secretary) that is
- 11 generally consistent with the percentage increases given

15	"(b) Eligibility.—A covered employee is eligible for
16	incident response premium pay under this section if—
17	"(1) the covered employee is deployed to re-
18	spond to a qualifying incident; and
19	"(2) the deployment described in paragraph (1)
20	is—
21	"(A) outside of the official duty station of
22	the covered employee; or
23	"(B) within the official duty station of the
24	covered employee and the covered employee is

1	assigned to an incident-adjacent fire camp or
2	other designated field location.
3	"(c) Entitlement to Incident Response Pre-
4	MIUM PAY.—
5	"(1) IN GENERAL.—A covered employee who
6	satisfies the conditions under subsection (b) is enti-
7	tled to premium pay for the period in which the cov-
8	ered employee is deployed to respond to the applica-
9	ble qualifying incident.
10	"(2) Computation.—
11	"(A) Formula.—Subject to subpara-
12	graphs (B) and (C), premium pay under para-
13	graph (1) shall be paid to a covered employee
14	at a daily rate of 450 percent of the hourly rate
15	of basic pay of the covered employee for each
16	day that the covered employee satisfies the re-
17	quirements under subsection (b), rounded to
18	the nearest whole cent.
19	"(B) Limitation.—Premium pay under
20	this subsection—
21	"(i) with respect to a covered em-
22	ployee for whom the annual rate of basic
23	pay is greater than that for step 10 of GS-
24	10, shall be paid at the daily rate estab-
25	lished under subparagraph (A) for the ap-

1	plicable rate for step 10 of GS-10 (where
2	the applicable rate is the rate in effect in
3	the same locality that is the basis for a lo-
4	cality-based comparability payment payable
5	to the covered employee under section
6	5304); and
7	"(ii) may not be paid to a covered em-
8	ployee in a total amount that exceeds
9	\$9,000 in any calendar year.
10	"(C) Adjustments.—
11	"(i) Assessment.—The Secretary of
12	Agriculture and the Secretary of the Inte-
13	rior shall assess the difference between the
14	average total amount of compensation that
15	was paid to covered employees, by grade,
16	in fiscal years 2023 and 2024.
17	"(ii) Report.—Not later than 180
18	days after the date that is 1 year after the
19	effective date of this section, the Secretary
20	of Agriculture and the Secretary of the In-
21	terior shall jointly publish a report on the
22	results of the assessment conducted under
23	clause (i).
24	"(iii) Administrative actions.—
25	After publishing the report required under

clause (ii), the Secretary of Agriculture and the Secretary of the Interior, in consultation with the Director of the Office of Personnel Management, may, in the sole and exclusive discretion of the Secretaries acting jointly, administratively adjust the amount of premium pay paid under this subsection (or take other administrative action) to ensure that the average annual amount of total compensation paid to covered employees, by grade, is more consistent with such amount that was paid to those employees in fiscal year 2023. "(iv) CONGRESSIONAL NOTIFICA-TION.—Not later than 3 days after an adjustment made, or other administrative action taken, under clause (iii) becomes final, the Secretary of Agriculture and the Secretary of the Interior shall jointly submit to the appropriate committees of Congress a notification regarding that adjustment or other administrative action, as applicable. "(d) Treatment of Incident Response Premium Pay.—Incident response premium pay under this sec-25 tion—

1	"(1) is not considered part of the basic pay of
2	a covered employee for any purpose;
3	"(2) may not be considered in determining the
4	lump-sum payment of a covered employee for accu-
5	mulated and accrued annual leave under section
6	5551 or section 5552;
7	"(3) may not be used in determining pay under
8	section 8114;
9	"(4) may not be considered in determining pay
10	for hours of paid leave or other paid time off during
11	which the premium pay is not payable; and
12	"(5) shall be disregarded in determining the
13	minimum wage and overtime pay to which a covered
14	employee is entitled under the Fair Labor Standards
15	Act of 1938 (29 U.S.C. 201 et seq.).".
16	(b) Additional Premium Pay Amendments.—

16	"(b) Rest and Recuperation Leave.—
17	"(1) In general.—A covered employee may
18	receive paid rest and recuperation leave following the
19	completion of service in which the covered employee
20	is deployed to respond to a qualifying incident, sub-
21	ject to the policies prescribed under this subsection.
22	"(2) Prescription of Policies.—The Sec-
23	retary of Agriculture and the Secretary of the Inte-
24	rior shall, in the sole and exclusive discretion of the
25	Secretaries acting jointly, prescribe uniform policies

1	described in paragraph (1) after consulting with the
2	other applicable Secretary.
3	"(3) Content of Policies.—The policies pre-
4	scribed under paragraph (2) may include—
5	"(A) a maximum period of days in which
6	a covered employee is deployed to respond to a
7	qualifying incident, which shall—
8	"(i) begin on the date on which the
9	covered employee departs from the official
10	duty station of the covered employee and
11	end on the date on which the covered em-
12	ployee returns to the official duty station
13	of the covered employee; and
14	"(ii) be followed by a minimum num-
15	ber of days of rest and recuperation for the
16	covered employee; or
17	"(B) a requirement that prohibits a cov-
18	ered employee from working more than 16
19	hours per day on average over a 14-day period
20	during which the covered employee is deployed
21	to respond to a qualifying incident.
22	"(c) Use of Leave.—
23	"(1) IN GENERAL.—Rest and recuperation
24	leave granted under this section—

1	"(A) shall be used during scheduled hours
2	within the tour of duty of the applicable covered
3	employee established for leave-charging pur-
4	poses;
5	"(B) shall be paid in the same manner as
6	annual leave;
7	"(C) shall be used immediately after a
8	qualifying incident; and
9	"(D) may not be set aside for later use.
10	"(2) No payment.—A covered employee may
11	not receive any payment for unused rest and recu-
12	peration leave granted under this section.
13	"(d) Intermittent Work Schedule.—A covered
14	employee with an intermittent work schedule—
15	"(1) shall be excused from duty during the
16	same period of time that other covered employees in
17	the same circumstances are entitled to rest and re-
18	cuperation leave; and
19	"(2) shall receive a payment as if the covered
20	employee were entitled to rest and recuperation leave
21	under subsection (b).".
22	(b) Technical and Conforming Amendment.—
23	The table of sections for subchapter II of chapter 63 of
24	title 5, United States Code, is amended by inserting after
25	the item relating to section 6329d the following:

"6329e. Rest and recuperation leave for employees engaged in wildland firefighting.".

1 SEC. 5. TRANSFER AUTHORITY.

- Notwithstanding section 40803(c)(2) of the Infra-
- 3 structure Investment and Jobs Act (16 U.S.C.
- 4 6592(c)(2), not more than \$5,000,000 of the unobligated
- 5 balances of amounts made available under the heading
- 6 "WILDLAND FIRE MANAGEMENT" under the heading
- 7 "Forest Service" under the heading "DEPARTMENT
- 8 OF AGRICULTURE" in title VI of division J of that Act
- 9 (Public Law 117–58; 135 Stat. 1410) pursuant to section
- 10 40803(c)(2)(B) of that Act (16 U.S.C. 6592(c)(2)(B))
- 11 may, as necessary to continue uninterrupted the Federal
- 12 wildland firefighter base salary increase described in sec-
- 13 tion 40803(d)(4)(B) of that Act (16 U.S.C.
- 14 6592(d)(4)(B)), be transferred to and merged with the
- 15 amounts made available under the heading "WILDLAND
- 16 FIRE MANAGEMENT" under the heading "DEPARTMENT-
